

Rules

CAN YOU FESTIVAL GRANT Competition organized by Nordic Wristbands

1. Participation

In order to enter the Competition, you must

- 1) before 30 March 2020 (24.00 CET) fill in a form at <http://nordicwristbands.com/en/festival>
- 2) be a registered company or an organization that
 - has its registered address and an office in Europe
 - has maximum of 4 years of operation
- 3) be organizing an event for which you are applying the grant that is not bigger than 10.000 visitors as daily capacity

We are accepting only one entry per applicant company.

Please note that applying for the grant does not require that you buy anything or pay any fees or any other consideration to us.

2. Selection of the winner

Nordic Wristbands' Judge Panel shall select the company that will be given out the grant. The Judge Panel shall value the following criteria in applicants:

- fulfilment of conditions listed in Section 1 of these rules (e.g. that the entry has been sent on time)
- potential of the event
- ecologic approach of the event
- innovativeness of the event

3. Prizes

The confirmed prize for the year 2020 is:

4000 euros for wristband purchases and 500 euros for lanyard, id card and other related products' purchases from Nordic Wristbands.

The winners shall be contacted to their e-mail address given in the application form the week before the May 2nd 2020. Nordic Wristbands reserves the right to try to contact the winner also by other means but it does not undertake to do so.

In case Nordic Wristbands receives no response from the winner within three (3) days from the initial contact by Nordic Wristbands a second name shall be chosen. The process shall continue until the prize is duly delivered to the winner.

THE WINNER SHALL ALSO BE ANNOUNCED ON MAY 2ND 2020. However, if Nordic Wristbands has not been able to reach the winner before the announcement date, Nordic Wristband reserves a right to delay the announcement.

The prizes might be subject to local taxation in your own country. The winner shall itself pay those taxes. The price is inclusive of a VAT of 24% if applicable to the winner.

4. Publicity

We would like everyone to know about the winner's excellent event and would like to make a press release about the grant and its winner. By submitting your application form you give us a permission to use your company and event name in our press release and our other company communications regarding the grant.

5. Limitations and Other Terms

Should there be no applicants fulfilling the requirement(s), Nordic Wristbands reserves the right to not produce the grant at any given year.

No grant will be awarded as a result of improper actions by or on behalf of any entrant.

The employees of Nordic Wristbands of its affiliates, as well as members belonging to the same household, are not permitted to enter into the Competition.

The winner cannot require Nordic Wristbands to provide money in the grant's stead, e.g. in a case when the entire monetary amount of the grant is not used by the grant winner.
